

RESOLUTION NO. 2021- 10

RESOLUTION OF THE COUNTY OF DEWITT REGARDING COUNTY REAPPORTIONMENT

Whereas, the County of DeWitt is a body politic in the State of Illinois responsible for the County of DeWitt and its units of county government; and,

Whereas, the County of DeWitt is required pursuant to Chapter 55, Illinois Compiled Statutes 5/2-3002 (a) to reapportion County Board Districts every 10 years; and,

Whereas, the County of DeWitt wishes to remain a twelve (12) member board of four (4) districts with three (3) members being elected from each district, with no cumulative voting; and,

Whereas, the County of DeWitt wishes to adhere to 55 ILCS 5/2-3003, the prescribed statute in its reapportionment plan, in that:

1. The Districts be of equal population.
2. The Districts be contiguous (as nearly as possible).
3. No township or municipality be divided (unless necessary).
4. No precincts have multiple Districts (unless necessary).

Whereas, proposed Map, copy attached, meets the requirements of the above referenced statutes.

BE IT THEREFORE ORDAINED, that the County of DeWitt reapportions its County Board Districts Into four Districts of three members each as shown on Map, a copy of which is attached hereto and incorporated herein by reference.

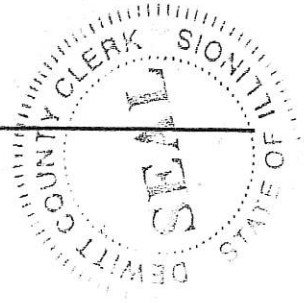
