## Resolution for Salary and Expenses of DeWitt County Engineer SECTION 23-00000-00-CS & 23-CS039-00-AC

WHEREAS, the County Board of DeWitt County, hereafter County, has entered into an agreement with the Illinois Department of Transportation, hereafter IDOT, for transfer of federal funds to pay one-half of the salary paid to the County Engineer provided said salary is at least ninety-five percent (95%) of the salary recommended by the Department of Transportation, State of Illinois, hereafter IDOT; and,

WHEREAS, the County adopts this resolution establishing the salary of the County Engineer to be \$122,409.20 from July 23, 2023 to July 22, 2024; and,

WHEREAS, said amount is greater than ninety-five percent (95%) of the recommended salary for the County Engineer as determined by IDOT,

NOW, THEREFORE, BE IT RESOLVED, by the County that there is hereby appropriated the sum of one hundred twenty-two thousand four hundred nine and 20/100 dollars (\$122,409.20) from the County's Motor Fuel Tax funds for the purpose of paying the County Engineer's salary from July 23, 2023 to July 22, 2024; and,

BE IT FURTHER RESOLVED, that the County does hereby authorize IDOT to transfer sixty-one thousand two hundred four and 60/100 dollars (\$61,204.60) from the County's allotment of Federal Surface Transportation Program Funds to IDOT provided IDOT returns an equal amount of State funds to the County for payment of one-half of the salary of the County Engineer; and,

BE IT FURTHER RESOLVED, by the County that there is hereby appropriated the sum of three thousand and 00/100 dollars (\$3,000.00) from the County's Motor Fuel Tax funds for the purpose of paying the expenses of the County Engineer.
